What is it about?

The objective of the talk is to present the research about indigenous and local communities (IPLCs) participation provisions in the Draft Agreement of an international legally binding instrument on the conservation and sustainable use of marine biological diversity of areas beyond national jurisdiction (BBNJ) under the United Nations Convention on the Law of the Sea (UNCLOS) to discuss whether they will lead to sustainability on the high seas.

These draft provisions about IPLCs' participation have been analysed taking into account democratic features of environmental participation and decisions of human right bodies concerning participation. Moreover, Water Framework Directive (WFD) and Marine Strategic Framework Directive (MSFD) provisions have been analysed, as well as possible contributions from the CBD and the United Nations Framework Convention on Climate Change (UNFCCC).



The talk will be held by **Prof. Dr. Violeta Radovich**. She is a researcher at the Argentine Council on Scientific and Technical Research (CONICET).

She did her doctorate on Maritime Law as well as her masters (LLM) in Environmental Law at the University of Buenos Aires.

She works as a professor at the Universidad de la Defensa Nacional, the Universidad Nacional de San Martín and the University of Buenos Aires.

The talk is organized to present her research, which is part of a fellowship program of the University of Bayreuth Centre of International Excellence "Alexander von Humboldt" (Bayreuth Humboldt Centre). Her fellowship is hosted by Prof. Dr. Eva Julia Lohse.
